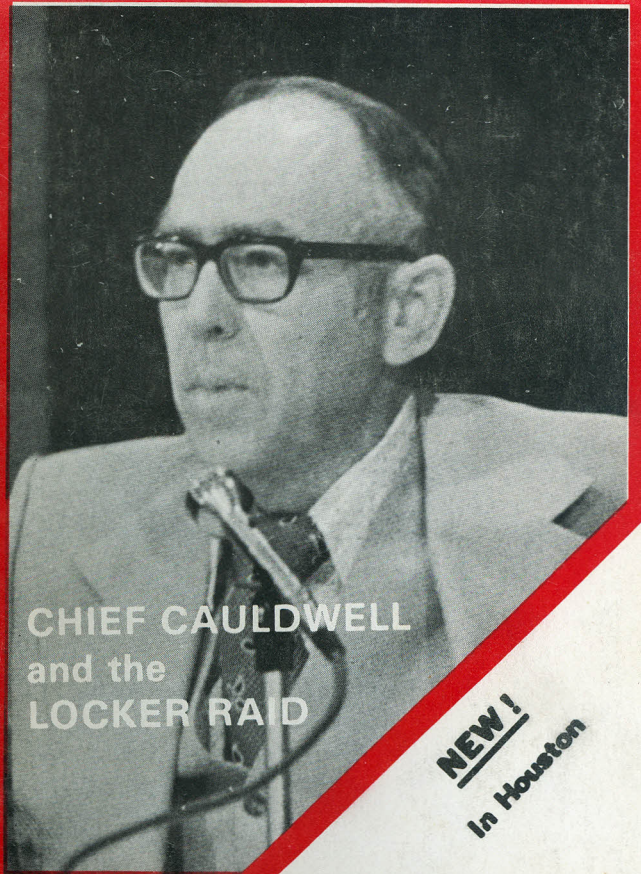

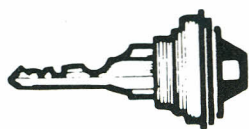

THE LOCKER RAID or...

In the very late hours of Wednesday, January 18, about 11:45 P.M., **The Locker**, one of Houston's better known 'Leather' bars, was subjected to one of the increasingly frequent raids by officers of the Houston Police Department. Approximately twenty officers, were involved, some armed with shotguns and semi-automatic rifles, according to eyewitness accounts of the incident. Only seven or eight individuals were actually charged with some crime and taken to police headquarters. Raid activities ended at about 12:30 A.M. and business at **The Locker** continued as usual.



"You fellers is in a heap o'trouble."



The onset of the raid was signaled not by the traditional police whistle blast, but rather by an observant **Locker** employee tending the door. His suspicions were aroused by the appearance of an H P D paddy wagon and squad car in the front parking area of the bar. Word of the arrival was quickly passed to those inside. Lights were brought up and the music turned down to alleviate any confusion which might have otherwise resulted from communication problems with the raiding officers. Almost simultaneously, one of the 8 or 9 plainclothes police officers who had apparently been in the bar for quite some time, instructed all those present to "Take out one piece of identification and put your hands up against the wall or the bar".

By this time, a uniformed Houston Police sergeant and approximately 10 uniformed officers entered the building and proceeded to collect identification from all present. Those unable to produce any form of identification were taken into custody for "failure to provide identification to a law enforcement officer". (*Ve vant to see your papers. . . hmmm?*) A check was made for outstanding wants or warrants on all those who did produce identification leading to the arrest of a few more persons. There appeared to be a total of seven or eight arrests made. In addition to the charges previously mentioned, at least two persons were arrested

on a charge of "public lewdness", two others for "assaulting a police officer", and an unknown number for "public intoxication". **LXIX** has no information as to the validity of these charges at the present time.

The public was first made aware of the raid soon after it began when a call was received at the studios of Pacifica Radio station **KPFT** where the Gay Community program **WildenStein** was being aired. **Ray Hill**, a well-known Houston area Gay activist and host of the **WildenStein** program announced to the listening audience that a raid was rumored to be in progress at **The Locker** and that he would personally investigate the situation. **Hill** arrived at **The Locker** at approximately 12:15 A.M. and found a raid to indeed be in progress. He asked several pointed questions of the officers involved, particularly questioning the need for so many officers and such heavy armament (*Are we all that dangerous? -Ed.*) in a relatively small crowd situation, bearing in mind last week's raid at **The Old Plantation**. **Hill**, himself, was not arrested and by 12:30, all raid activity at **The Locker** had ended.

In a Thursday afternoon conversation with **Ray Hill**, the staff of **LXIX** was assured that accountability for this incident would be sought, beginning with the office of the Chief of Police, **Harry Caldwell**. (*See cover.*) **Hill** further stated that he was disturbed by the incident, particularly in light of a recent statement by **Chief Caldwell** to the effect that he will not tolerate harassment of the Gay Community. (*See related story - Page*) Perhaps, as in the issue of pornography, a clear community definition of 'harassment' is needed as there are obviously conflicting opinions.

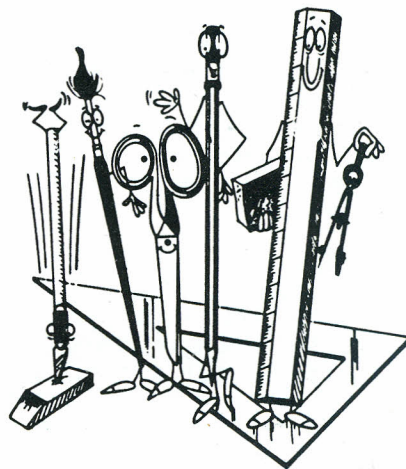

Review

The Dave Kopay Story by David Kopay and Perry Deane Young

(Bantam paperback, \$1.95; available at Wilde 'n' Stein Books)

Former pro football player David Kopay and former UPI correspondent and author Perry Young, himself gay, join hands (or typewriters) in this revelation of Kopay's coming out of the "Jock's closet," the last "sanctified bastion of masculinity" (read "rigid heterosexuality"), and spells out the surprising range of reactions/responses of professional colleagues, friends, family and sports officials/writers, as well as Kopay's personal agonies and joys in the process.

Of course, the uniqueness of **The Dave Kopay Story**, a very readable book, is that Kopay is the first major professional sports figure to openly state his homosexual preference, an admission validated by his 10 years' credentials as a running back for the Forty Niners, the Saints, the Lions, the Redskins and the Green Bay Packers.

Inspired by a series of interview articles in the **Washington Star** dealing with dozens of anonymous gay athletes, Kopay decided to lend his name to the breaking of important ground in sports journalism and the Gay Liberation movement. It was, indeed, a courageous and badly needed "coming out."

Of course, many of us know (as certainly Kopay knows) that there are many gays in the pro sportsworld. One, the most famous and outrageous pro backfielder of all, is the occasional and special guest of one of Houston's most affluent (and semi-closeted) gays at his beautiful townhouse adjacent to Westheimer. Another gay athlete, a well-known Houston backfielder, was the recent subject of an out-of-the-blue remark by a national sportscaster who blurted out "Look at ____! He sure does run funny!" His unnerved co-broadcaster hurriedly changed the subject.

Community Panel Discusses

Last Wednesday night, Houston Police Chief **Harry Cauldwell** appeared on a panel discussion of homosexuality at Congregation Beth Yeshurun. In sharp contrast to the activities of the Houston Police Department just a few hours later, when a Gay bar was raided (*See related story, pg. 4*), **Chief Cauldwell** attempted to present an image of a liberal, broadminded public official.

"What is the attitude of the police to homosexual bars, clubs, groups, churches? It is the same as it is toward heterosexual clubs, groups, churches", said the chief.

Earlier in his opening statement, **Chief Cauldwell** indicated that the HPD had more important things to do than involve itself in the homosexual's private affairs. "Generally," said the Chief, "what persons opt to do privately couldn't be of less concern..."

Rabbi Segal, who moderated the panel, asked a series of questions spanning the homosexual experience in society. With **Chief Cauldwell** on the panel were **Dr. Ed Reitman**, a clinical psychologist, and **Rabbi Aaron Blumenthal** who classified himself as a "big C" conservative.

Dr. Reitman, while generally sympathetic to homosexuals, referred several times to the gay lifestyle as, "atypical, deviant, and abnormal", when judged against society's accepted standards. When asked by the moderator whether homosexuals should be allowed to bring up children, **Dr. Reitman** referred to an imposing list of homosexuals and bisexuals in history pointing out that many famous persons were or would

teachers. He stated that he saw no reason for Gays not to be allowed to teach, as long as they did not attempt to teach their own sexuality.

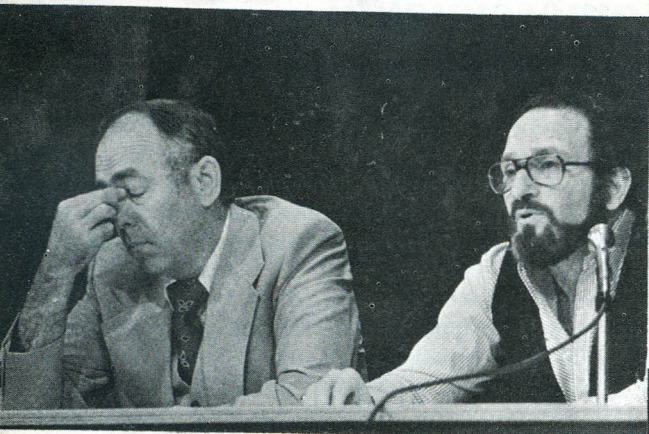
One of the outstanding moments of the evening came when **Rabbi Blumenthal** was asked about the religious aspects of homosexuality. In reply to the question, "What does the Bible say about homosexuality?", **Rabbi Blumenthal** answered in part, "...so the question is not what does the Bible say that the Bible condemns. The question is, is the Bible right to condemn it?" The Rabbi went on to point out that other condemnations of the Bible are no longer valid. He noted that as knowledge becomes greater our concepts and judgements change. He cited the Biblical treatment of lepers as opposed to the advanced medical methods in use today.

Gay activist **Ray Hill** asked **Chief Cauldwell**, "Last Thursday night you were overheard saying to a member of the legislature that the raids on the Gay bars prior to the rally were necessary to keep some semblance of control. I would be interested in what you meant by that statement; the statement was later verified by the member of the legislature."

Chief Cauldwell replied, "...due to the concentration of officers in the district, they observed significant numbers of drunks falling around on the ground in there and staggering around the bars and this violated the law, so that I think that the legislator, whichever one he is, says that the arrests were involved in a Gay rally. I don't even know when the homosexual rally was, but I know when the arrests were, and they were not timed to coincide with anything but a bunch of drunks falling all over themselves in a bar holding a beer licence. And the same thing will happen the next time the drunks are served in a bar joint; whether it is homosexual bars or heterosexual bars, or other bars."

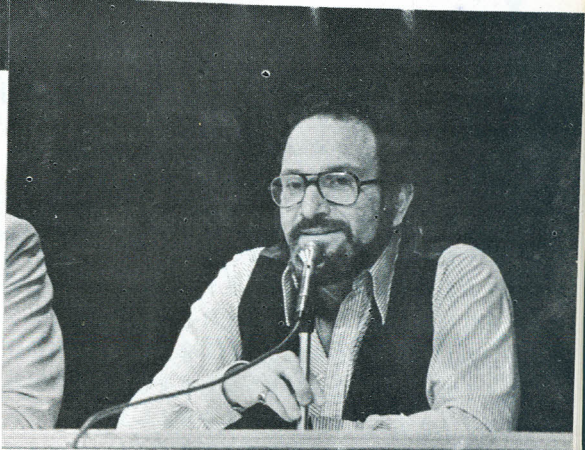

Is that you ?

In an apparent step-up of police activity, groups of Houston Police officers began entering and roaming about Gay bars. No arrests have yet been reported. Tuesday night between 11 and 12 p.m. **The Locker**, one of Houston's more popular "leather" bars, was visited by several pairs of uniformed officers. Over at **The Silver Bullet** a similar visit took place, with officers armed with flashlights peering into the treehouse (*Thanks for the compliment HPD, but even Gays couldn't make out in that kind of weather. - Ed.*) and generally making things uncomfortable for the patrons and management. It is hoped that this is not a resurrection of police tactics of the fifties, using their presence to discourage customers from exercising their free choice.

This escalation in Police activity came just a week after **Chief Cauldwell** stated in a public meeting (*See related story, pg. 14*) that the department would be concerning itself with the more serious crimes rampant in Houston.

An informed source within the Police Department states that the Gay Community can expect a "lot of problems with **Chief Cauldwell**".

Any responsible journalist is loathe to print anything of a third hand nature. Heresay is often unreliable, motivated by the personal interests of the teller rather than any dedication to truth. However, in this case, we are making an exception because of the unique series of events that are occurring now in our community.

Sentiment reportedly expressed by some vice squad members was that a highly placed official will allow the **HPD** to enforce the law as it sees fit, and that he will back them 100%. The official supposedly stated that he would have no meeting with any 'Goddamned queers' while in office.

We must hasten to point out that this is exactly opposite to recent public statements by **Chief Cauldwell** that the Police Department would tolerate no harassment of any minority group by police officers.

Ray Hill, representing the Gay Community, has been unable to obtain a meeting with the Chief of Police. In lieu of the Chief, he met Tuesday with **Assistant Chief R.G. McKeehan**. As of this time, **Hill** has not received any indication of when **Chief Cauldwell** will be available or even if the Chief will see any representative of the Gay Community. When **Mr. Hill** contacted the Mayor's office he was told, "the Mayor's office is seriously concerned". Unfortunately, the **Mayor** is out of town and cannot be contacted directly about the rising wave of police harassment.

Gary Van Ooteghem and **Hill** are currently organizing a leadership meeting to plan a response to this very serious threat to the Gay Community.

When asked what advice this publication could pass on to the members of our community, **Ray Hill** replied, "This is an extremely grave situation. Avoid any direct confrontation with members of the Houston Police Department; or violence could result."

The situation is grim. . . avoid any appearance of resistance to a police officer. . . keep cool and report any direct information concerning police harassment (with the badge number, if possible) to the **Gay Political Caucus** at 526-2668 or to **Ray Hill** at 453-1143.

Wayland Flowers & 'MADAME'

Wayland Flowers and Madame appeared this week at The Old Plantation to capacity crowds in what was advertised as a "Pre-Broadway Engagement".

As usual, the Houston Gay Community was an enthusiastic and receptive audience. Wayland's talents captivated the crowd, centering attention on his characters. The pace was brisk and the material a fine mixture of classic Madame and the more topical.

One of the best received lines of the evening was during "Jiffy's" (the black puppet) routine. In response to a query from the audience about Anita Bryant, Jiffy said, "You people aren't goin' to let a Produce seller put you down?"

The characterizations ranged the spectrum of comedy; Madame referring to her good friend Maude (For God's Sake Maude, put on your fucking glasses") was the penultimate irreverent old hqrror. Jiffy was the earthy street-wise hooker telling the crowd, "Momma told me a long time ago, don't look fo' no pie in the sky, get you a piece now - - with ice cream on it!"

Crazy Mary, a self-styled refugee from Bellvue, was the most outrageous and possibly the most touching of Wayland's friends. The redheaded dummy typified the institutionalized social loser who uses the very system that oppresses her against itself, "Nurse, if you don't tell me I'll throw a fit . . . good, I knew you would."

Let us not forget Mr. Flowers, who makes the characters come alive, until it is the character, and not Wayland Flowers, that the audience sees.

The Old Plantation deserves a large Thank You for bringing the charming Wayland Flowers and company to Houston. We had hoped to bring you some photo coverage of the performance, but unfortunately our camera was stopped at the door. For those of you that missed these two nights, we can only hope that it will not be too long before The Madame again visits Houston.

HUMAN RIGHTS - II

Anita Bryant visited Houston for the second time in seven months January 9. Her visit was preceded by a second **Houston Human Rights Rally** at City Hall park. braved freezing temperatures and winds to protest the singer's appearance before the **American Farm Bureau Federation** convention at the Civic Center.

After singing at the Farm Bureau convention **Bryant** said "We have a responsibility more than ever before not to let evil forces take America under." **Bryant** sang several religious songs, signed autographs, and received a standing ovation from the farmers.

The rally was called by local Gay community leaders to show support for civil rights for gays and voice displeasure with **Bryant's** anti-gay campaign.

Local gay-rights supporters spoke before the crowd, beginning with **Ray Hill**, long-time Gay activist. **Hill** told the crowd, "**Anita Bryant** is no threat to us. However, the thoughts and ideas she promotes are very dangerous to us as human beings. Her ideas threaten our very existence and safety."

State Representative **Ron Waters**, whose District 79 includes Montrose, spoke about the constitutional issues raised by **Bryant's** outspoken beliefs. "All Americans, Gay and straight, have the right to say what they please. However, they also have the right to live as they please with the same privacy that each American has been taught is his due. We have just as much right to live as we wish and to associate with those we choose as **Anita Bryant** has to say what she wants."

MCCR's pastor, **Rev. Jeri Harvey** spoke about the teachings of the Bible as they pertain to the lives of Gays and straights. "No where in this Bible does it say that Gays are not loved and accepted by **God** as much as **Anita Bryant** is. No where does it say that we do not have the right to as much love and respect from our fellow human beings as **Anita Bryant**. She uses this

book to condemn us. I say this book preaches that we should love our neighbor, not condemn them simply because they are different than we."

Former **GPC** chairman **Gary van Ooteghem** told the crowd about the effects of prejudice on the working person. "I was fired from a good job with Harris County because I am Gay. I suffered what so many of our brothers and sisters have suffered and will continue to suffer. Job discrimination such as this will continue until prejudice such as **Anita Bryant's** is overcome."

Toward the end of the rally the crowd was led in songs such as "We Shall Overcome." Virtually every-one attending joined in the songs.

Media coverage of the rally was considered excellent. News teams from all three local TV network affiliates covered the rally on their late evening programs. Both local daily newspapers sent reporters, as did a team of reporters from a Dallas paper in town to cover the Farm Bureau convention. Several local radio stations also sent reporters to cover the rally.

The only incident during the rally was stopped by the police before it started. A group calling themselves **Freedom's Heritage Society** passed out anti-gay literature at the perimeter of the City Hall park. Uniformed Houston Police Department officers, at the rally by invitation of the organizers, moved the group to an area across the street from City Hall where they were allowed to pass out their literature.

Police officers were most cooperative with the rally organizers and stated that they were there to protect the rally from any outside trouble as well as to prevent trouble.

Hill termed the rally a success and announced that "**Anita Bryant** will know by our presence here tonight that whenever she comes to Houston she will be met with protest until she drops her anti-gay campaign."

INSTANT RALLY — *Just add Ray*

Ray Hill has the reputation of being able to organize anything at almost a moment's notice. And that reputation is well-deserved.

Hill says that the second human rights rally was organized with only four days notice. "An anonymous member of the local media called me on Wednesday morning with the news that **Anita Bryant** was coming to town. Between the time I was notified and the Wilden-Stein radio show that evening, I had determined that it was probable that we should hold another rally."

"During the show we put the question to the listeners. Of all the listeners that called in, only one voiced a negative opinion for a rally. We then decided to hold another rally, this time at City Hall."

Hill said the rally was organized by a group mainly consisting of the radio show staff, some of the community leaders and a number of people who had never before been involved in political actions such as rallies.

"Within four days we had made several dozen signs, posters, and banners. We had arranged for a sound system, and several speakers. We also determined that it would be in our best interests to have the cooperation of the city police department in the advance planning of our rally so that there would not be any violence. The rally was carried out with the police department in obvious attendance so that there would be no trouble from within the crowd or from outside agitators. A **Captain Higgins** was in charge of a contingent of more than fifteen officers, both on foot and in vehicles. We had several doctors in attendance with an ambulance so any medical problems could be taken care of quickly."

Hill commented that it was amazing that a rally of this sort could be conceived of, planned, publicized, and carried off in only four days. "I believe that if the need arises, we have proven that we can hold a rally for practically anything with very short notice."
