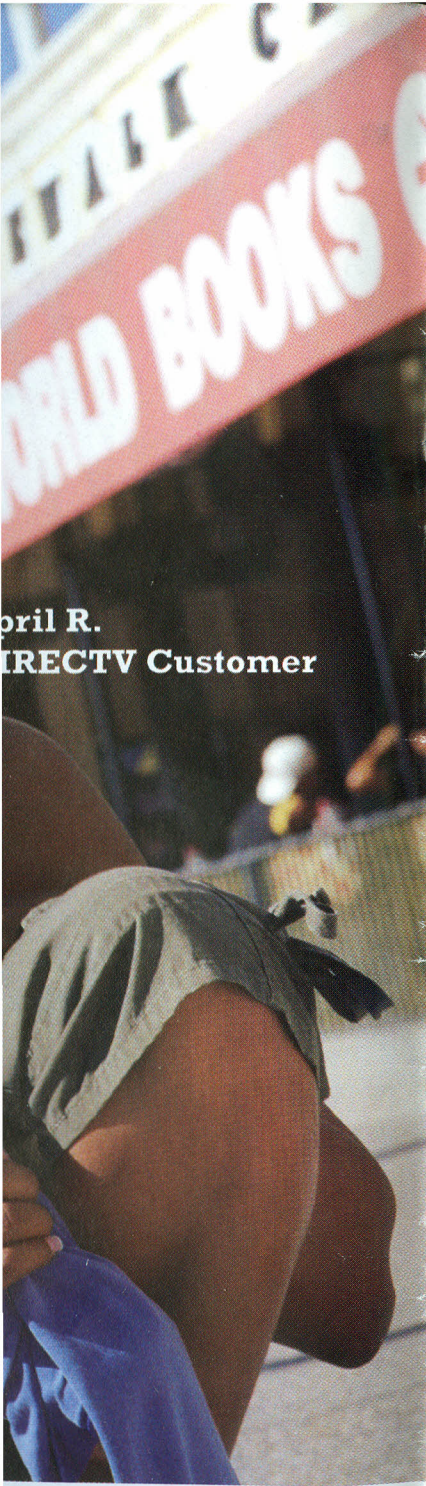

Proposition 2 foes will counterprotest Klan's 'anti-homosexual-marriage' rally

Opponents of a constitutional amendment to ban same-sex marriage said they will stage a counter-protest near an "anti-homosexual marriage rally" sponsored by the Ku Klux Klan.

The American White Knights division of the Klan says the rally is to promote "pro-family values" by encouraging people to vote against Proposition 2, the ballot measure containing the amendment. They have asked Austin city officials for permission to use the plaza at City Hall.

The group promised that speakers would not be inflammatory.

The No Nonsense in November campaign plans to have a vigil in the middle of a bridge over Town Lake. Participants will be asked to sign a pledge of nonviolence, coordinators said.

Opponents of the proposal have also scheduled a Sunday event at the state Capitol. Rep. Senfronia Thompson, a Houston Democrat, will speak.

"I think it's going to have a very negative effect. For the very first time, we would be altering the state Constitution in order to discriminate," said Susan Melnick, a Dallas real estate agent.

Melnick is speaking, of course, about Proposition 2, the ballot measure

A law already exists doing the same thing. Melnick says the message from the constitutional amendment's supporters is clear: "We're going to take away rights you don't even have yet," she laughed.

But that's the way things work sometimes in the topsy-turvy world of Texas politics.

Laura Overton, 50, is a retail manager, and her partner, Donise Whited, 40, works in operations in an architectural firm. They live in the Houston Heights neighborhood with their cat and three dogs. On Tuesday the women said they planned to vote early — and vote against Proposition 2.

"We've been together for over 15 years. We own our own home, pay our taxes," Whited said. "We don't believe that we need a piece of paper to validate our commitment, so we haven't had a commitment ceremony, and we don't plan to."

Last year, doctors told Overton she had breast cancer.

Report offers details about Latin gay couples

There are more than 100,000 United States households containing Latin same-sex couples, and about 8,000 are in the three largest metropolitan areas of Texas, according to a report based on data from the 2000 Census.

The report, released Tuesday by the National Gay and Lesbian Task Force, was a product of its think tank, the

Policy Institute. Its author is Jason Cianciotto, the institute's research director.

Cianciotto said in a telephone interview on Tuesday that the report indicates anti-gay public policies have a harsher impact on Latin than Anglo gay and lesbian couples.

Gay Latin couples are similar to straight Latin couples, Cianciotto said.

"They have similar rates of home ownership. They speak Spanish at home at about the same rate," he said.

But strong differences arose between Latin and white same-sex couples, he added.

"Hispanic same-sex families earn significantly less than white same-sex families. They parent at higher rates. They serve in the military at higher

rates, and they own their own homes at lower rates," Cianciotto said.

Certain public policies aggravate the difference, including a policy to prohibit same-sex marriages, he said.

"Many of the federal benefits and protections of marriage are designed to help families save money, buy their own home and provide for their children," Cianciotto explained. "So you have these families that are already economically disadvantaged, and these policies hurt them even more."

Among Latinos, 54 percent of lesbian couples and 41 percent of gay couples are raising at least one child. In addition, 33 percent of men and 26 percent of women said they were not U.S. citizens.

Cianciotto pointed out that since they are unable to marry, they are unable to sponsor a non-citizen same-sex partner for immigration purposes. He claimed this threatened the stability of gay Latin families since about half include at least one child.

But Cianciotto said the report is "not just about marriage. There are a number of issues we looked at, like the rate these couples use public assistance, the military and implications for gay and lesbian elders on a variety of issues including Social Security privatization and Medicare/Medicaid reform."

Among the report's other findings:

- Same-sex couples in which both partners are Latino earn about \$25,000 less than white same-sex couples.
- Latino same-sex couples are about three times more likely to be raising children than their white counterparts. Latina same-sex couples are twice as likely to be raising children as their white counterparts.
- Latinas in same-sex couples serve in the

military at a higher rate, despite risking the loss of their income and benefits because of the ban on out GLBT service members. Latinas in same-sex couples report military service at six times the rate of Latina women married to men, and at six times the rate of all women nationwide.

• About 43 percent of same-sex families in which both partners are Latin report owning their own homes, compared to 72 percent of white same-sex couples.

Cianciotto said he hopes the information in the report will help empower GLBT Latinos community to "stand up, to come out and say, 'We exist. We deserve equality and our families deserve respect from our government and from our own communities.'"

Cianciotto said he hopes non-Latin gay men and lesbians will use the report to learn more about GLBT Latino people, "so that we can work together to become a more cohesive movement and combat the divide-and-conquer tactics of the right wing."

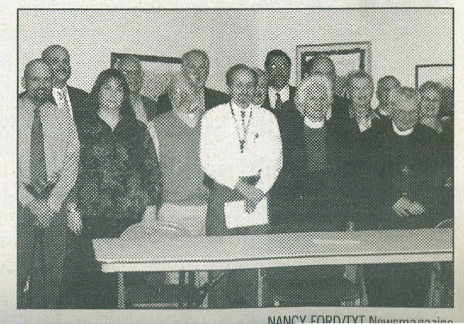

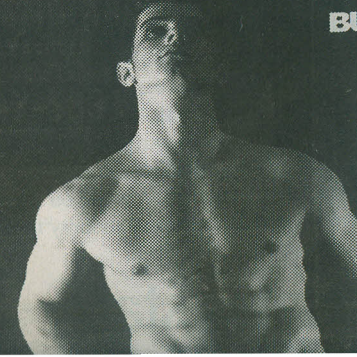

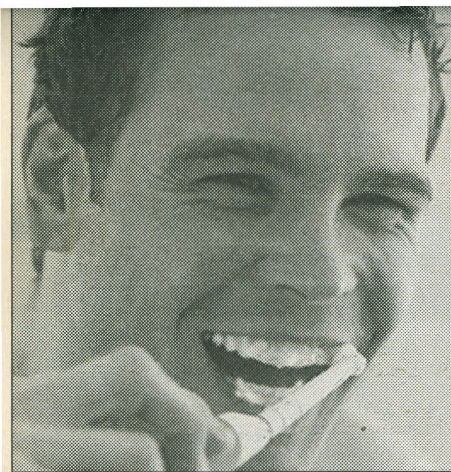

"We see this as a clear issue of simple justice. Proposition 2 denies basic civil rights our church supports," said the Rev. Glynden Bode, chairperson of the Texas Conference United Methodist Board of Church and Society.

Despite doctrinal differences between various representatives, they agreed that Proposition 2 is over-broad and unnecessary.

Rabbi Shaul Osadchey of Congregation Or Ami called himself "a Jew against 2," because he believes that sexual intimacy "is not God's exclusive gift to heterosexuals."

The Rev. Dr. Belinda C. Windham, interim associate pastor at St. Philip's Presbyterian Church, agreed.

"Jesus Christ did not utter a single syllable about sexual orientation," she said. "All he preached was unconditional love."

Speculating on why opponents to same-sex marriage who cloak themselves in God's love have pushed Proposition 2, Emerson Unitarian Church's Rev. Mark Edmiston-Lange said he believes that "fear has led us to this day."

Gay leaders state opposition to conservative replacement for retiring Justice O'Connor

The nomination of Judge Samuel Alito to the Supreme Court was greeted with a now-familiar chorus of concerned rhetoric and calls from the GLBT community for tough confirmation hearings. But there was a deeper sense of outrage and frustration in the tone of the community's response.

WASHINGTON "President Bush chose to placate the far right instead of appealing to the fair-minded values of the American people," said Joe Solmonese at the Human Rights Campaign. Over at Lambda Legal, legal director Jon Davidson said Alito's "track record on reproductive freedom, enforcement of civil rights and federalism ... raises red flags." Stonewall Democrats charged President Bush with appealing "the socially conservative political activists who control the Republican party and this White House." And National Gay and Lesbian Task Force executive director Matt Foreman characteristically declined to mince words:

"President Bush capitulated to the howling from the extreme, evangelical right and threw them red meat in the form of U.S. Circuit Court Judge Samuel Alito," he wrote. "The country will now be put through a wrenching, divisive and damaging confirmation process, one more travesty inflicted on this nation by the president and his right-wing allies."

On Wednesday, the *New York Times* reviewed 15 of Alito's abortion decisions, noting that a strong concept of marriage

Finally, to add to the early confusion, the *Boston Globe* reports that Alito chaired a student task force on privacy rights during his senior year at Princeton that recommended an end to hiring discrimination based on sexual orientation, and the repeal of sodomy laws.

Alaska's top court mandates state equalize benefits for gay workers

The Alaska Supreme Court issued a unanimous ruling ordering the state to institute equal benefits for gay and straight employees. The decision states that the denial of domestic

partner insurance and other job perks to partnered gay state workers violates the state constitution's equal protection clause.

"Denying benefits to the same-sex domestic partners who are absolutely ineligible to become spouses has no demonstrated relationship to the interest of promoting marriage," wrote the court.

Filed by the American Civil Liberties Union in 1999, the suit sought to mitigate the damage done by the passage of a constitutional amendment banning same-sex marriage in

November 1998. Alaska was one of two states to pave the way for the current spate of anti-marriage amendments. Hawaii also amended its constitution in response to court rulings in favor of same-sex couples.

Alaska Governor Frank Murkowski said he was outraged by the decision and pledged to help pass yet another constitutional amendment that would ban domestic partner benefits.

The ruling reversed a lower court decision against the plaintiffs, nine gay and lesbian couples with state jobs. Both sides will now submit briefs advising the court on how best to eradicate the discrimination.

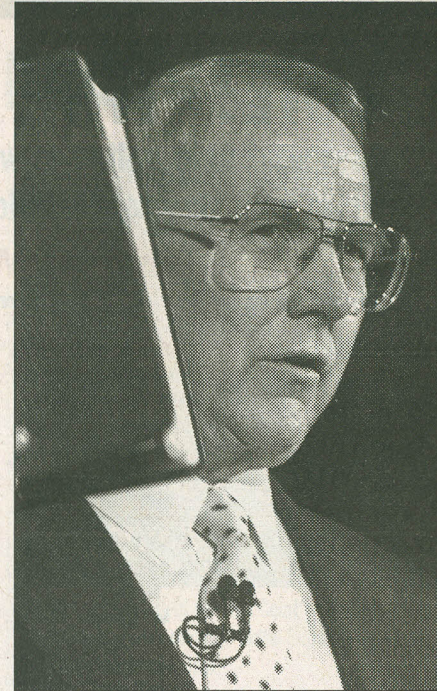

In 1955, there were few who paid attention to African-American history. When Parks defied authority, she became a civil rights role model. At a time when Negroes were beaten and brutalized or killed at worst, Rosa Parks defied racial pride, social justice and the need for African-American history.

The GLBT community should take a lesson by highlighting our pioneers, heroes and heroines. African-Americans take rightful pride in Parks, Martin Luther King, Jr., Barbara J. Rustin, Jackie Robinson and other trailblazers who demanded that their history be respected.

It helps us understand our place in history as a civil rights movement. 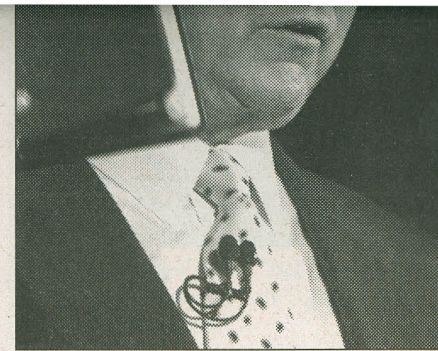

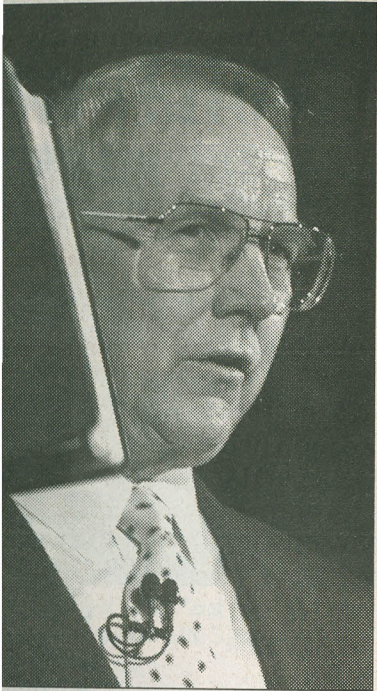

Almost 50 years ago on a Montgomery, Ala., bus, Rosa Parks, then a middle-aged seamstress, refused to give up her seat to a white man. Her non-violent defiance fueled the African-American civil rights movement and serves as a model for gay, lesbian, bisexual and transgender activism.

In 1955, there were few who paid even nominal attention to African-American history. When Rosa Parks defied authority, she became a civil rights pioneer and a role model. At a time when Negroes were marginalized at best and brutalized or killed at worst, Rosa Parks symbolized racial pride, social justice and the need to teach African-American history.

The GLBT community should take a page from that lesson by highlighting our pioneers, heroes and civil rights history. African-Americans take rightful pride in Rosa Parks, Martin Luther King, Jr., Barbara Jordon, Bayard Rustin, Jackie Robinson and other trailblazers. The framework of the current debate in Texas regarding Proposition 2, the amendment to ban same-sex marriage and all other forms of gay unions, most often draws on perspectives rooted in civil rights, morality and religion. Discussion focuses only rarely on the economic consequences of such legislation.

That needs to change. As America's businesses are increasingly acknowledging, policies that promote equality and
